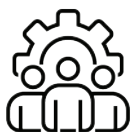
REQUIREMENTS



Start a new business, with each applicant having at least 10% of Voting Rights.



Business must have potential to create employment for Canadians, excluding immediate family members.



Actively manage the business in Canada.



Show sufficient Settlement Funds. No minimum investment required.



Meet language requirements, generally equivalent to CLB Level 5.



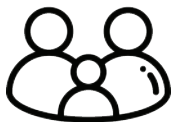
