THE MALTA PERMANENT RESIDENCE PROGRAMME (MPRP)





MALTA PERMANENT RESIDENCY PROGRAM: YOUR GATEWAY TO A NEW HOME

The MPRP allows for the granting of permanent residency in Malta for individuals and their families who contribute to the economy of Malta. The programme offers significant value to clients wishing to make Malta their home away from home.

By virtue of the residency cards, successful applicants are also given the opportunity to travel within the 29 countries making up the Schengen zone for 180 days per year. Once residency is attained, applicants may opt to find employment and/or set up a business in Malta or Gozo.



Eligibility Criteria

To be eligible for the MPRP, applicants should:



1. Be third country nationals and not Maltese, EEA or Swiss nationals;
2. Not benefit under any other relevant Malta government scheme;
3. Be in receipt of stable resources to maintain himself and dependents without recourse to the Maltese social assistance system;
4. Be in possession of a valid travel document;
5. Show capital assets of not less than €500,000, out of which a minimum of €150,000 must be financial assets;
6. Be fit-and-proper individuals and have a clean criminal record;
7. Not pose any potential threat to the national security, public policy, public health or public interest.

Programme Benefits

The following benefits are granted to successful MPRP applicants:

1. The right to settle, stay and reside permanently in Malta;
2. Freedom of movement – enjoy Visa-free travel across Schengen, 90 out of 180 days;
3. A residency card that supports employment opportunities;
4. Unique business opportunities and grants for prospective investors;
5. A residency programme that allows four generations of families to apply;
6. Access to top-notch education based on the British curriculum;
7. Second to none healthcare system;
8. The opportunity to experience Malta's Mediterranean quality of life.





Contributions

Rent Property Option

- Pay a Government contribution of €98,000;
- Pay €2,000 towards Non-Governmental Organisations;
- Rent property for a minimum annual value of €10,000 (Gozo/South of Malta) or €12,000 (North of Malta) for 5 years;
- Pay an additional €7,500 for each additional adult dependant (except for the spouse);
- Purchase health insurance covering Malta for each applicant.



Purchase Property Option

- Pay a Government contribution of €68,000;
- Pay €2,000 towards Non-Governmental Organisations;
- Purchase property for a minimum value of €300,000 (Gozo/South of Malta)
- 350,000; (North of Malta) and hold for 5 years;
- Pay an additional €7,500 for each additional adult dependant (except for the spouse);
- Purchase health insurance covering Malta for each applicant.
