ABOUT EB5

USCIS administers the EB-5 Immigrant Investor Program, which was created by Congress in 1990 to stimulate the U.S. economy through job creation and capital investment by foreign investors. Under a program first enacted as a pilot in 1992 and regularly reauthorized since then, investors also qualify for EB-5 classification by investing through regional centers designated by USCIS based on proposals for

promoting economic growth. On March 15, 2022, President Biden signed the EB-5 Reform and Integrity Act as part of the Consolidated Appropriations Act, 2022 (Public Law 117-103), which created new requirements for the EB-5 immigrant visa category and the Regional Center Program. Immigrant visas are authorized under the Regional Center Program through Sept. 30, 2027.

INVESTMENT SUMMARY

Invest USD 800,000 into a USCIS approved Regional Center Project within qualified Targeted Employment Area (TEA), creating and maintaining 10 full time jobs for 2 years straight.

STEPS & TIMELINES

The following Timeline outlines the Process & Steps to be taken by the Client to become USA Citizen.

PROCESS:

Immediately

Step 1

Applicant selects an investment option and starts application preparation. Applicant signs the EB5 Regional Center offering documents and engages and EB5 attorney as advised by Secondpass Global. Advisory and Legal fees are due at this stage.

1 Month

Step 2

Applicant transfers investment and regional center fees into a nominated escrow account of the selected Regional Center.

1 - 2 Month

Step 3

Applicant works with Secondpass and Immigration Attorneys packaging on source of funds documents for filing Immigrant Petition by an Alien Entrepreneur Application (I-526). The USA immigration attorney lodges the I-526 application with USA National Visa Center (NVC).

12 Months

Step 4

Immigration Petition I-526 is approved by U.S. authorities in Approx. 12 months or less for Rural TEA projects and up to 24 months for standard TEA projects

2 - 5 Months

Step 5

For clients outside USA, visa application (DS-230) is lodged with local U.S. Counsel or Embassy in home country. Applicant and family may be subject to biometric tests, medical and health screening. An interview with the applicant may be requested and conducted. All original documents should be available. Visa is approved and stamped in applicant's passport. Conditional Green Card is issued.

Immediate - Max 180 Days

Step 6

Applicant and family must enter the U.S. within 180 Days. 2 Year conditional Green Cards are issued.

2 - 3 Years

Step 7

After residing in U.S. for 2 years, Secondpass Global and the USA Immigration Attorney will submit I-829 Petition to remove conditions on Green Card. I-829 Petition is approved approximately in 8 to 9 months after submission. Client can apply for Citizenship after holding Green Card for 5 years and living in USA for 2.5 years out of 5 years.
